- 1. The Board of Trustees of the Township of Lyons held its Regular Board Meeting on Tuesday, March 12, 2019 at 6:00 p.m. in the Town Hall, 6404 Joliet Road, Countryside, Illinois 60525.
- 2. Supervisor Getty called the Meeting to order at 6:00 p.m.
- 3. Supervisor Getty called for the Pledge of Allegiance.

- 5. Trustee Kelly moved, Trustee Sprague seconded to approve the Regular Board Meeting Minutes of February 12, 2019 as presented. Voice Vote in favor by all. Motion Carried.
- 6. Supervisor Getty asked for a motion to approve a \$650.00 grant to Lyons Township Little League in support of their organizational 2019 Season. Supervisor Getty commented that he would like to form an Ad-hoc Committee made up of the Trustees and including the Clerk to review all proposals received. By a consensus of the Board it was agreed that a Special Meeting for the purpose of reviewing proposals regarding auditing services for the Township of Lyons would convene on April 3, 2019 at 6:00 p.m. in the Township Hall.
