### Construction Permit Requirements

1. Completed application for permit
2. Check payable to Lyons Township Highway Dept. in the amount of \$100.00 for new construction, demolition and room additions, \$50.00 for remodeling, repair permits, driveways where there is no structural change, fence permits, etc.
3. Plat of survey / site engineering plan
4. \$10,000.00 license and permit surety bond
5. Certificate of insurance with Lyons Township Highway Dept. as additional insured
6. County or Township variances will require additional engineering review fee.
7. New home construction may require additional engineering review fee.

### **Additional Driveway Requirements**

- 1. Maximum pavement width at easement / roadway  
24 ft. single drive and 40 ft. combined for multiple.**
- 2. Concrete or brick paver driveways must have an  
asphalt apron a minimum of 3 ft.**
- 3. Culverts are to be replaced to maintain drainage.**
- 4. Replacement culverts shall be at least 12 inches in  
diameter.**
- 5. Parkway must be restored to original condition.**
- 6. Saw cuts to roadway must be approved.**
- 7. Any modifications to original driveway  
dimensions require a topographical  
survey.**

10. The applicant further agrees to return the work site to a clean and orderly condition.

The applicant swears the above statements are true and correct, under penalty of perjury, and that the same are to induce the Highway Commissioner, Lyons Township Road District, to issue a Construction Permit. Work covered by this Permit shall not be initiated until this application has been reviewed and approved, and all Permit fees have been paid in full. Applicant shall properly notify the Lyons Township Road District when work is scheduled to begin so that inspection can be scheduled. Upon completion of the Permitted work and final inspection and approval by the Lyons Township Road District, said approval will be noted by the dated signature of the Highway Commissioner or his agent. Unless otherwise authorized, the permit shall be valid for a period of one hundred eighty (180) days from the date of issuance.

# Certification
