GENERAL TOWN, GENERAL ASSISTANCE AND SPECIAL POLICE PROTECTION
BUDGET APPROPRIATION
MAY 28, 2020
(PRESENTED FOR APPROVAL AT THE MEETING OF JUNE 9, 2020)**

1. The Board of Trustees of the Township of Lyons held the Proposed Combined General Town, General Assistance, Special Police Protection Budget Appropriation Public Hearing on Thursday, May 28, 2020 at 6:00 p.m. Meeting was held via conference call due to the COVID-19 Pandemic.

2. Supervisor Getty called the Meeting to order at 6:04 p.m.

3. Clerk Porfirio called the Roll and the following were present:

Also, in attendance was George Pach, Deputy Clerk; Sean McDermott, Township of Lyons Highway Commissioner; Elizabeth Shine, Attorney with Odelson, Sterk, Murphey, Frazier, McGrath, Ltd.; and Township Employee Mary VanAllen. Supervisor Getty, Clerk Porfirio and Highway Commissioner McDermott were physically present at the meeting.

4. Supervisor Getty read the following statement in relation to the Public Notice of the Hearing which had been published and posted according to State Statute.

“On April 14, 2020, the Township Board authorized the display of the Tentative Budget & Appropriation Ordinance for the General Town, General Assistance & Special Police Protection, a copy of which was on file and available for inspection by any interested party, with electronic copy posted to the Township Website. Also, on April 14, 2020, the Township Board directed the Township Clerk to schedule a public hearing for consideration of the Tentative Budget & Appropriation Ordinance, notice of which was posted and published in the Township at least 30 days prior to the time of this hearing, in compliance with all applicable laws.

The General Town fund beginning cash amount was changed to \$2,893,865.00 from \$3,671,431.00 due to the accidental inclusion of cash balances that are reported in other funds.

Estimated income in the Park Bonds Debt Service fund increased from \$2,200.00 to \$537,800.00 as a result of the addition of property tax revenues of \$535,600.00 to pay current year principal and interest due for the Series 2015 bond. This revenue source has been budgeted for and received annually since the issuance of the related debt. The final bond principal and interest payments related to the Series 2015 bonds are due in December 2020.”

5. Supervisor Getty asked for a motion to approve the Proposed 2020/2021 Combined General Town, General Assistance and Special Police Protection Budget as presented.

Trustee Garrette moved, Trustee McDonald seconded to approve the Proposed 2020/2021 Combined General Town, General Assistance and Special Police Protection Budget as presented.


