Supervisor Getty asked for a motion that the Township Hall Building Renovations Bid be awarded to All Construction Group, 1425 55th Ct., Cicero, IL 60804 which had submitted the lowest base bid at \$498,000.00. Supervisor Getty reported that the other construction companies that had submitted bids were Berglund Construction, 8420 South Chicago Avenue, Chicago, IL60617 @ \$625,000.00; JLJ Contracting, 2748 South 21st Avenue, Broadview, IL 60255 @ \$702,430.00; and D Kersey Construction Company, 4130 Timberlane Drive, Northbrook, IL 60062 @ \$724,400.00. Mr. Ken Nadolski, architect with API Architects, the company which will be overseeing the proposed renovations, stated

that all of the bid proposals had been reviewed by API Architects in regard to contractor qualification requirements required by the American Institute of Architects (AIA) and that no concerns or disqualifying attributes had been found in either of the two lowest bidders and therefor recommends that All Construction Group be awarded the Renovation Contract.
