As your elected Supervisor of the Township of Lyons, I will continue to work with The Town Board to provide services to all residents of Lyons Township.

The Township Senior Transportation service is free of charge to our senior residents and those with a disability. Lyons Township is one of the remaining few townships in the State of Illinois that still does not charge a fare for senior transportation and is funded with Township property taxes. This program did not stop providing rides during the COVID-19 Pandemic.

Since 2012, the Township, in partnership with Community Memorial Foundation and Greater Chicago Area Food Depository, sponsors monthly mobile food banks to our residents each year. Dates and sites are posted on our website at [www.lyonstownshipil.gov](http://www.lyonstownshipil.gov). Volunteers from the host sites, St. Blasé Parish in Summit, Village of Justice and the Pleasantview Fire Protection District in Hodgkins distribute the food.

Grants were approved by the Town Board to support not for profit agencies that provide youth, senior, disabled and family orientated programs.

The Township's Summer Intern Work program employed thirty-seven Township college-aged residents. The interns worked over 11,874 hours at seventeen agencies within the Township.

I would like to thank all of the employees and volunteers of the Township of Lyons. It has been a pleasure to work with our Town Board and I commend their dedication to improving the quality of life for residents of the Township of Lyons.

YEAR IN REVIEW 2020-21**

The Township of Lyons Clerk's office is proud to highlight the progress we have made in 2020 to provide resources to our community, as well as create a more informed society. We strive to provide open and transparent government to the Township of Lyons.

The Township's website is regularly updated with important information, including events within the Township, public health information, and board meeting agendas and minutes. The website is user-friendly and all documents are easy to access.

Residents can come into the Clerk's office to have documents notarized. Two notaries are at the public's service.

The Clerk's office collects tattered and worn American flags so they can be disposed of in an appropriate manner.

Pop tabs can be brought to the Clerk's office; they're donated to the Ronald McDonald House to raise money for the charity.

Typically, the Clerk's Office holds the Mobile I.D. and I-CA\$H program annually. The program enables residents to obtain a new driver's license, an Illinois State ID card, renew their license plates, and have their vision tested. In addition; our residents can make claims to get money back from the Illinois State Treasurer. The office also hosts the AARP Defensive Driving class; a course in which adults aged 50 years and above are given an opportunity to refresh their driving skills and earn a discount on their auto insurance. We hope to provide both these programs to our residents in 2021.

The Clerk's Office was able to provide 44 temporary Handicap Placards to our residents while they awaited their permanent one from the Secretary of State in Springfield.

The Township proudly maintained its status as an official Complete Count Committee with the U.S. Census Bureau and pledged to ensure everyone within the Township is counted once, only once,

and in the right place in 2020. The Clerk's Office also aided in Census efforts by helping residents apply to work for the Census, as well as offering resources to ensure residents were able to complete the Census.

Efforts to facilitate residents to apply to become election judges through the Township were also successful. Election judge positions were regularly advertised on the Clerk's social media platform as well as the Township website.

The Clerk's Office ensured it supported residents throughout the COVID-19 pandemic. The office consistently updated its website and social media platforms with COVID-19 updates, local testing sites, and best practices to keep safe during the pandemic.

The Clerk's Office initiated the #CantStoptheVote coalition in order to continue voter registration and information efforts throughout the COVID-19 pandemic. The coalition consists of members from the community as well as organizations such as the League of Women Voters, Illinois Muslim Civic Coalition, Arab American Family Services, and Sawtu. Numerous online events and social media campaigns were held under the coalition. Events included a webinar with Clerk Karen Yarbrough to inform residents about the different methods by which they can vote during the pandemic, and a virtual watch party the night of the general election. A community "Drive Thru" event was also held by the coalition; the event provided over 200 residents with the resources to fill out the Census, register to vote, and apply for a mail-in ballot, as well as doubling as a food and school supply drive. The event was drive-through style to ensure residents' safety. Regular phonebanks were hosted in which about 20 volunteers at a time called on the community to help them create a plan to cast their ballot, as well as answer any voting related questions they had.

Residents continued to look to the Clerk's office for help with absentee ballots and voter registration amidst the pandemic. Hundreds of residents were assisted in filling out absentee ballot and voter registration applications online and over the phone.

Vehicle Stickers for those living in the unincorporated areas of Lyons Township are now only available through the Cook County Department of Revenue at [wheel.tax@cookcountyil.gov](mailto:wheel.tax@cookcountyil.gov) or by calling 312-603-7301. However, if you need assistance in transmitting any of your information to the Department of Revenue please stop by our office and we will be happy to help you.

I also hope you find this year's Annual Book interesting and helpful. We do our best to provide valuable information and deliver excellent service!

The Assessor's Office and Clerk's Office have been participating in the Toys for Tots campaign for the last 5 years. Each year, the amount of toys donated by our taxpayers increases. We appreciate all the support they have given. This helps underprivileged children receive Christmas gifts that may not have received otherwise.



We continue to collect pop tops to give to the Ronald McDonald House. It takes approximately 1,128 pop tabs to equal **one pound**. They typically receive between **\$0.40** to **\$0.50** per pound of pop tabs. This program brings in an average of **\$6,000** each year. They use this money to fund the Ronald McDonald House.

**OFFICE OF THE ASSESSOR  
ANNUAL REPORT 2020-2021**



The year 2020 brought many changes for all of us. Due to the Covid-19 Pandemic, my office had to adapt in many ways to continue to serve the residents of the Township of Lyons. In 2020 we were able to move our appeals to almost an entirely virtual format. This allowed our residents to stay home and safe while receiving the help that they needed. Despite the pandemic we were able to provide several outreach opportunities. We partnered with the Cook County Assessor's Office and the Cook County Board of Review to provide multiple Facebook Live and other virtual events for our residents. Moving into 2021, we are now processing 100% of our Exemptions online. We will continue to adapt to make the process of appeals and exemptions convenient and safe for our residents.

Each month we send out an emailed newsletter to over 7,500 residents. This newsletter is a valuable tool to keep our residents informed and always in touch with important deadlines. We are open 5 days a week, Monday through Friday 8:30 a.m. – 4:00 p.m. **We are closed for our lunch hour between 12:00 and 1:00 p.m.** Watch for special hours during appeal times along with outreaches.



Back in May of 2020 the Cook County Assessor's Office reassessed all of the properties in Lyons Township. This happens every 3 years. You all received a "**Notice of Proposed Assessed Valuation**" in the mail. Any changes to your assessment will take effect on the 2<sup>nd</sup> installment tax bill that you will be receiving in July of 2021. This notice included an estimate of the proposed market value of your property and the proposed assessed valuation. A change in the rules for 2020 gave homeowners 35 days to file a Cook County Assessor appeal instead of thirty days. We are proud to say that we filed over 2,000 appeals virtually while keeping taxpayers safely at home.

Owning property in the United States involves many responsibilities. One of these is paying real estate taxes based on the value of your property. Real estate taxes are what you contribute to help pay for public services. Real estate taxes, for example, help pay for public education, libraries, park systems, sanitation services, police and fire protection. The overall amount of these taxes is determined when the agencies that serve you submit annual requests for money to operate.

The Township of Lyons Assessor's Office acts as a taxpayer advocate for residents in the Cook County Property tax system. Lyons Township consists of 17 Villages/Cities. They are Bedford Park, Bridgeview, Brookfield, Burr Ridge, Countryside, Hickory Hills, Hinsdale, Hodgkins, Indian Head Park, Justice, LaGrange, Lyons, McCook, Riverside, Summit, Western Springs, Willow Springs and the Unincorporated area. Our goal is to ensure taxpayers that their property is fairly and accurately assessed. Our job is to provide assistance and educate our taxpayers as they navigate through the property tax system.

**The Township Assessor *does not* set taxes, mail bills, or collect taxes.** Assessments do determine, however, what share of the overall taxes a property owner pays. Many factors contribute to figuring the value of your property. The main consideration is what properties similar to yours sold for in your neighborhood since the last reassessment.

The assessment rate is the level at which your property is assessed. Single family homes are assessed at 10%. The assessed value is the market value multiplied by the assessment level. The equalized assessed valuation (EAV) is the assessed valuation multiplied by the equalization factor. The equalization factor is a number determined each year by the Illinois Department of Revenue to even out or “equalize” by county, assessed values across the state. It is also known as the state “multiplier”.

It is important to note that the exemption amount is not the dollar amount by which a tax bill is lowered. EAV is the partial value of a property to which tax rates are applied; it is this figure on which a tax bill is calculated. The Department of Revenue sets the multiplier. The Clerk’s Tax Extension Unit sets the Tax Rate. Here’s how Tax rates are calculated:

- The Cook County Assessor’s Office establishes property valuations
- Taxing districts file their levy requests with the Clerk’s Tax Extension Unit.
- To produce the revenue requested, the Tax Extension Unit uses the levy to determine the tax amount to be “extended” against all properties located within the boundaries of the taxing district.
- The Clerk’s Tax Extension Unit determines the rate needed per \$100 of taxable value to generate the requested revenue, based on the value of all taxable property within the district boundaries.

#### **You can reduce your property tax bill by having:**

- **Homeowner’s Exemption** must be owner occupied as your primary residence as of January 1. The exemption is available to eligible taxpayers/residents of any age on their primary home. Once you have this exemption you do not need to apply again.
- **Senior Citizen Homestead Exemption** must be owner occupied and you must be 65 years old, (born in 1955) or older, regardless of income. Until 2019, state law required that senior citizens reapply annually for the Senior Exemption. The law changed on August 6, 2019 with the signing into law HB833. The bill amends the Illinois Property Tax Code to allow for the automatic renewal of the Senior Citizen Exemption for persons who had received this exemption in the year prior. Seniors not currently receiving the exemption, and those who turned 65 in 2020 must apply for the senior exemption in 2021; their exemption will then automatically renew the following year. If you received a Senior Exemption on the second-installment tax bill that you received in July 2020, you should not have to reapply for this exemption.
- **Senior Citizen’s Assessment Freeze** you must be 65 years or older with a total household income under \$65,000. Must be owner occupied for two full years as of Jan. 1. The Senior Freeze does not mean your bill will never change. The only thing that doesn’t change is your Equalized Value. The tax rates and multiplier still change which will change your tax bill.



**For tax year 2020 only, this exemption will automatically renew due to the Covid-19 pandemic. Newly qualified applicants must file an initial application in 2021.**

- **Disabled Person's Homestead Exemption** you must be disabled or become disabled for the tax year that you are applying for. The home must be owner-occupied as your primary residence as of January 1. This exemption must be renewed on a yearly basis. Having a Handicap Placard this *does not make* you eligible for this exemption.

**For tax year 2020 only, this exemption will automatically renew due to the Covid-19 pandemic. Newly qualified applicants must file an initial application in 2021.**

- **Returning Veterans Exemption** provides a one-time \$5,000 reduction in a property's equalized assessed value (EAV) to qualifying veterans who return from active duty in an armed conflict involving the armed forces of the United States. To receive this exemption, the veteran must file an application upon *their return home*.
- **Disabled Veterans Homeowner Exemption, Senate Bill 107**, the property must be owned and occupied by a disabled veteran or the surviving spouse, and the veteran must have a disability that is connected to military service. The law requires that the service-connected disability be certified by the US Department of Veterans Affairs, which determines the extent of a veteran's disability. The law provides that for taxable years 2015 and thereafter: veterans with 30%-49% service-connected disability receives \$2,500 annual exemption, veterans with 50%-69% disability receive \$5,000 annual exemption, and veterans with 70% or more disability are completely exempt from property taxation.

Houses with very high market values (*approximately \$917,000 or more*) are not eligible for this exemption. It should also be noted that if a disabled veteran dies and is survived by a spouse, the surviving spouse can retain the Disabled Veterans Exemption whether living in the current home or moving anywhere in Illinois. If the surviving spouse remarries the exemption will no longer be valid. This exemption started in 2015.

**For tax year 2020 only, this exemption will automatically renew due to the Covid-19 pandemic. Newly qualified applicants or applicants with an increased percentage of disability must file an initial application in 2021.**

- **Home Improvement Exemption.** This exemption encourages the expansion or renovation of homes by delaying taxation on up to \$75,000 worth of improvements for four years.

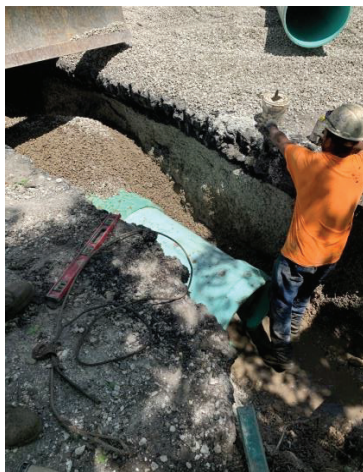

### GENERAL ASSISTANCE ANNUAL REPORT 2020-2021

2020 was a year we have never experienced in our lifetime. The COVID-19 Pandemic has affected everyone worldwide. As of the publishing of the Annual Town Report, Cook County is starting to administer vaccines. The Township of Lyons does not have a health center to administer the vaccines, but there is a Federally Qualified Health Center in our Township that is giving the vaccine, Pillars Community Health in La Grange. Residents can contact websites [coronavirus.illinois.gov](https://coronavirus.illinois.gov) and [vaccine.cookcountyil.gov](https://vaccine.cookcountyil.gov) for locations and appointments for the vaccine or call **833-308-1988**.

General Assistance is a State of Illinois program the Township of Lyons administers to improve the welfare of needy residents with financial assistance for basic living expenses. This program provides short-term assistance until individuals qualify for an appropriate State or Federal aid program or secure employment. Residents of the Township are assessed on property tax bills to fund the General Assistance Program. To be eligible for General Assistance, an applicant cannot be receiving funds through any other government program. The Township of Lyons employs a budgeting system pursuant to the Township Supervisors of Illinois General Assistance manual.

Residents are encouraged to contact the General Assistance office to find out what resources are available from Township, County, State and Federal programs.

Food pantries located in the communities work together with General Assistance to provide food from their pantries to local residents. The Township of Lyons partnered with the Community Memorial Foundation to fund twelve mobile food pantries through The Greater Chicago Food Depository. We would like to thank St. Blasé Parish Church in Summit, Pleasantview Fire Protection District in Hodgkins and the Village of Justice for hosting and providing volunteers for the Mobile Food Pantry program.

The Township of Lyons and the General Assistance Office would like to take this opportunity to offer our thanks and appreciation to those agencies and volunteers who serve residents across the Township of Lyons.

## **ANNUAL REPORT Fiscal Year 2020**



### **History & Overview**

The Lyons Township Mental Health Commission is charged by Illinois Statute to plan, fund and monitor community-based services for people with mental health and substance abuse problems, as well as for those who suffer from developmental disabilities. Created in 1972 pursuant to a township-wide referendum, the Commission provides community grants-in-aid and other funding to local agencies that provide direct services to Lyons Township residents in need. Funding is generated by a small annual property tax distributed by the Commission after careful planning and assessment of need. Since its inception over 40 years ago, the Commission has disbursed over \$78 million in community-based support to assist Lyons Township residents with these disabilities.

### **Mission Statement & Guiding Principles**

In all of its activities, and especially when making difficult decisions concerning the distribution of limited financial resources, the Mental Health Commission is guided by the following Mission Statement and Principles:

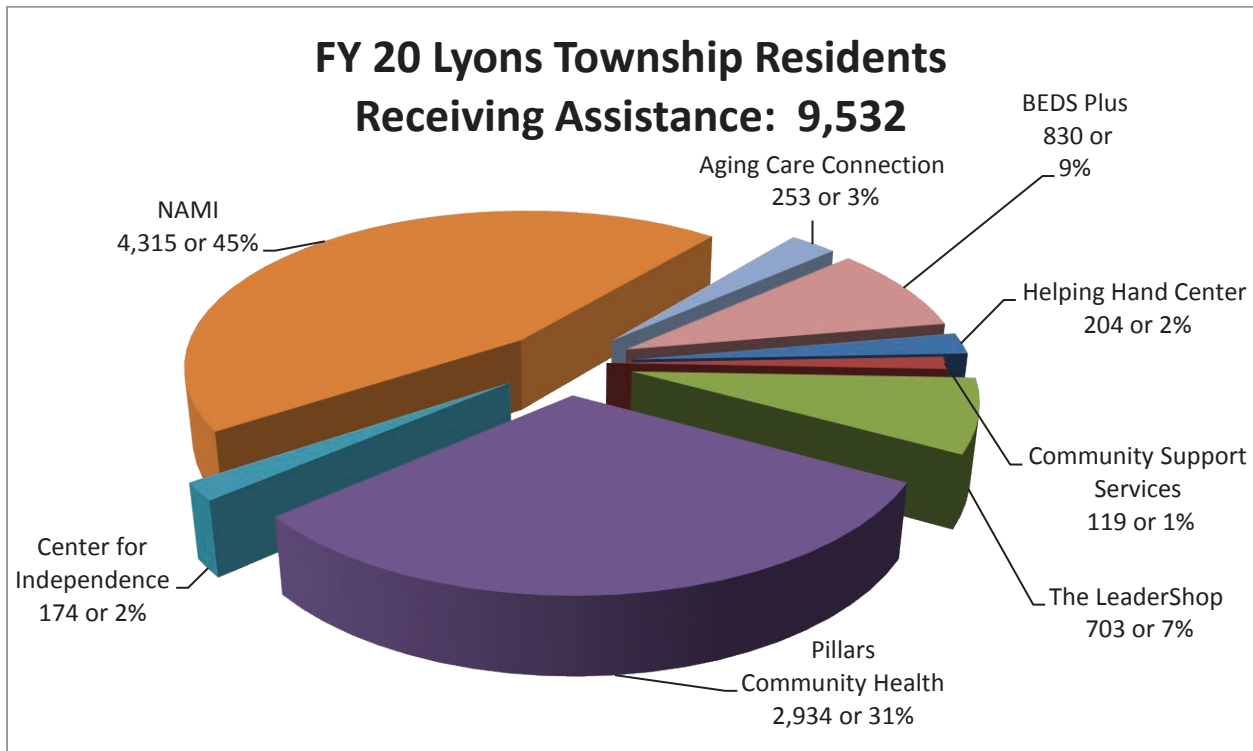

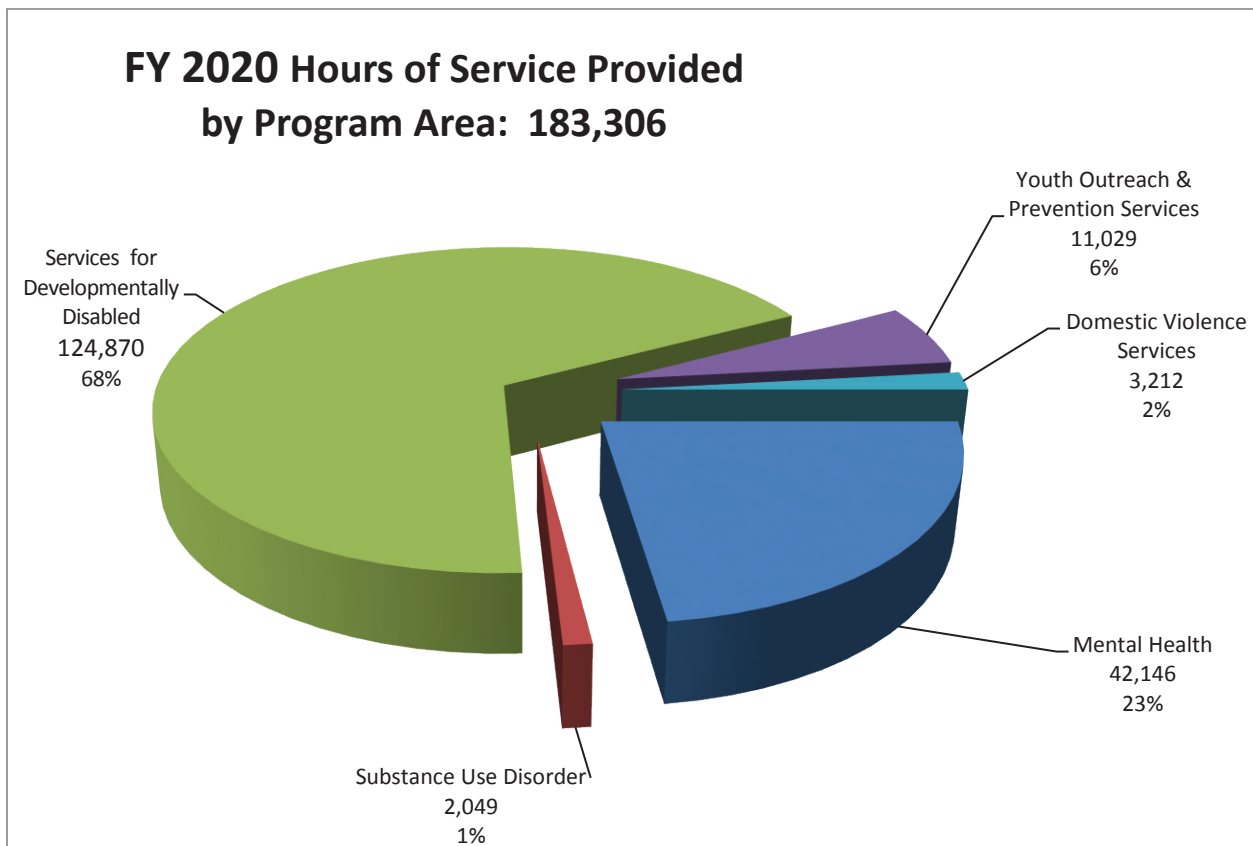

Percentage Distribution: \$3,689,095

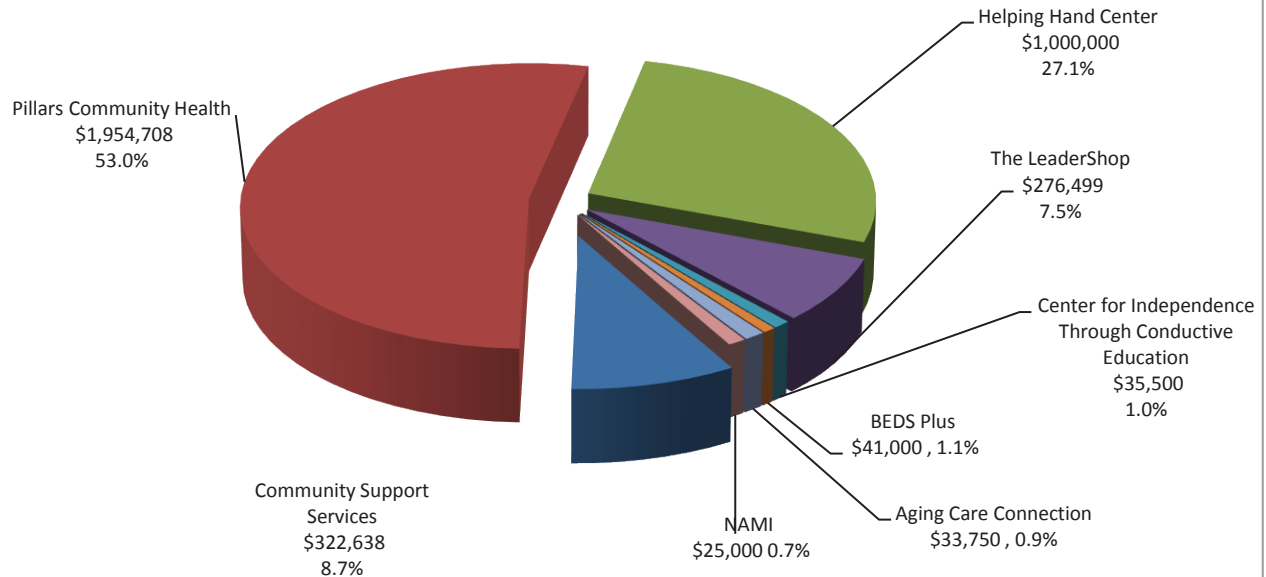

Percentage Distribution: \$3,689,095

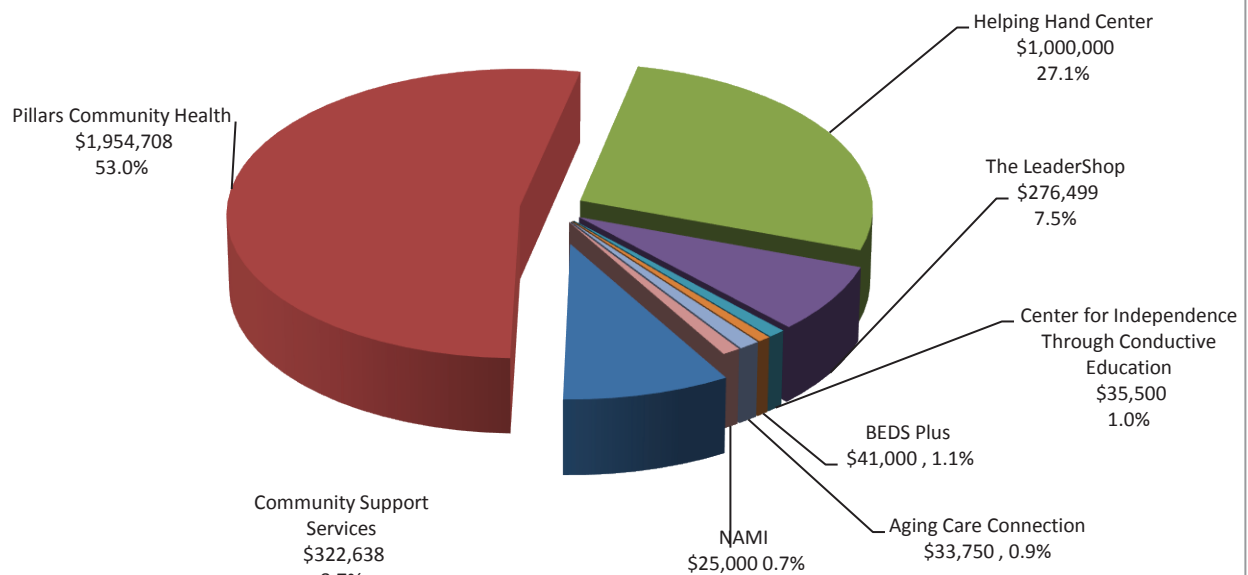
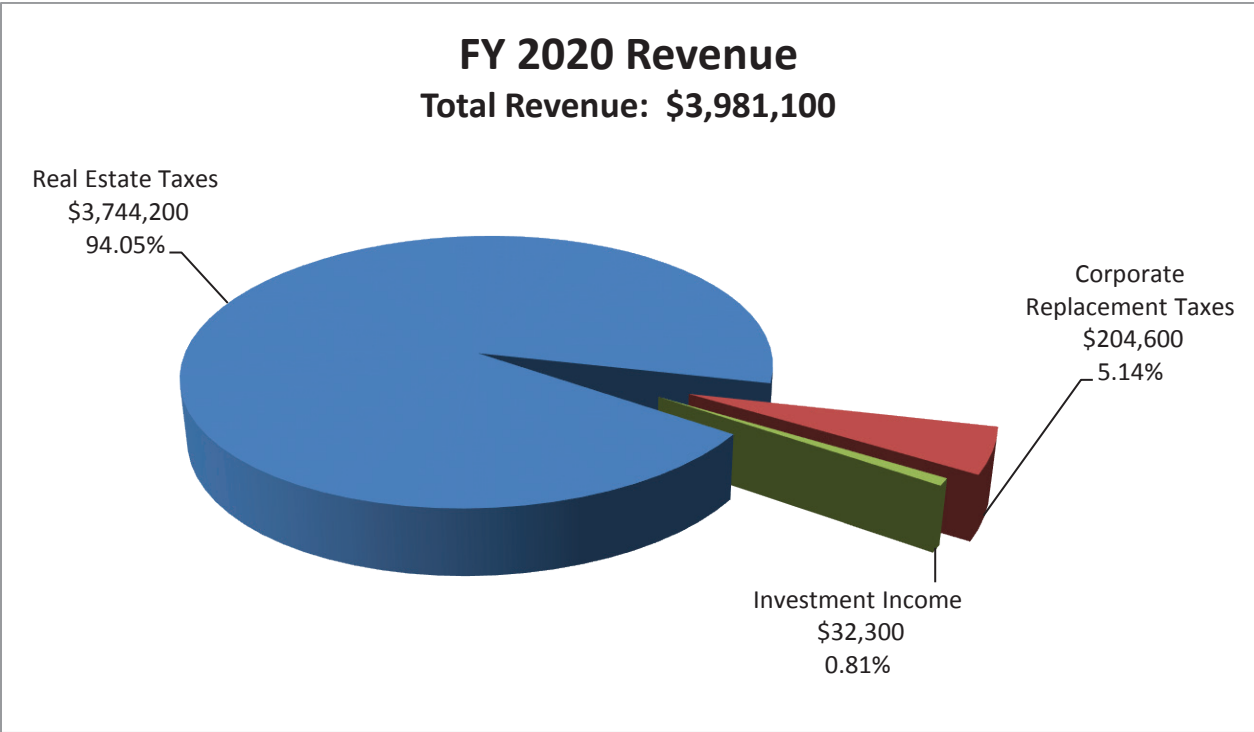
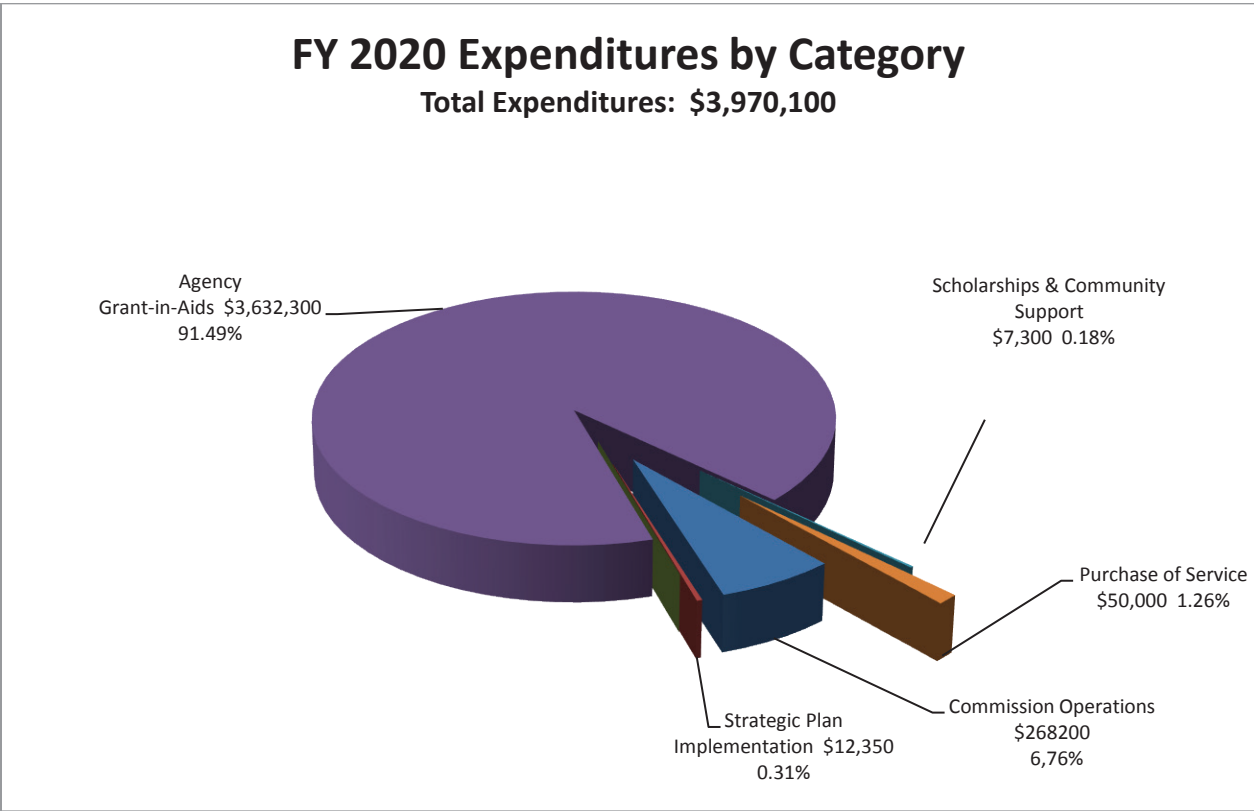
