- 1. The Board of Trustees of the Township of Lyons held a Special Board Meeting on Thursday, November 18, 2021 at 6:00 p.m. in the Town Hall, 6404 Joliet Road, Countryside, Illinois 60525 and via conference call due to the COVID-19 Pandemic.
- 2. Supervisor Getty called the Meeting to order at 6:05 p.m.
- 3. Supervisor Getty called for the Pledge of Allegiance.

5. Supervisor Getty asked for a motion to approve the 2021 Road & Bridge Drainage Improvements Contract from Copenhaver Construction, 75 Koppie Drive, Gilberts, Illinois 60136 in the amount of \$110,705.00.

Trustee Porfirio moved; Trustee Anderson seconded to approve the 2021 Road & Bridge Drainage Improvements Contract from Copenhaver Construction, 75 Koppie Drive, Gilberts, Illinois 60136 in the amount of \$110,705.00.

Due to the lateness of the season and change in recent weather, Highway Commissioner Sean McDermott stated that the work will commence in the Spring of 2022 at the earliest convenience between all parties involved. The contracted price will remain the same.

6. Supervisor Getty recommended an overall average increase of 0.12 % for the 2021 General Town Levy, General Assistance Levy, Special Police Protection Levy, and Road & Bridge Levy. This increase has been recommended after conversation with the Township Auditing Firm of G. W. & Associates and Township of Lyons' Finance Assistant Sherrie Marrotta.

Supervisor Getty commented that since this proposed increase in the Tax Levy is not at or above the statutory 5% increase cap, it will not require a Public Hearing before adoption. Upon conferring with the Township of Lyons' Clerk, Elyse Hoffenberg, Supervisor Getty stated that the adoption of the Levy could be an agenda item for the December 14, 2021 Township of Lyons' Regular Board Meeting so that the Levy may be filed with the Cook County Clerk before the deadline of December 28, 2021.

7. Trustee McDonald moved; Trustee Anderson seconded that the 2021 General Town Fund Levy, General Assistance Levy, Special Police Protection Levy, and Road & Bridge Levy be preliminary approved at an overall average increase of 0.12 %, to direct and authorize the Clerk that the Levy be prepared and hung according to state statute for 20 days and that the Levy Adoption date for such be set so that the General Town, General Assistance Levy, Special Police Levy, and Road & Bridge Levy can be filed with the Cook County Clerk before December 28, 2021.
