- 11. Clerk Hoffenberg mentioned that on Saturday, November 20, 2021 from 10:00 a.m. 1:00 p.m. Flu shots and Covid-19 Booster shots will be offered in the Community Room. Clerk Hoffenberg is hopeful that children's vaccines will be available as well.
