- 13. Clerk's Report Clerk Hoffenberg reported that the Township of Lyons provided Covid inoculations at the Indian Springs School District #109 Back to School Bash on Saturday, August 6, 2022 held at Wilkins Field in Justice, Illinois. Clerk Hoffenberg stated that the event was very well attended.
- 14. Clerk Hoffenberg commented that the Township of Lyons' Local Records Disposal is tentatively scheduled for Thursday, September 29, 2022 pending state archivist approval.
- Clerk Hoffenberg stated that the Clerk's Office will once again be hosting an Illinois Secretary of State Mobile ID program as well as I-Ca\$h run through the State of Illinois Treasurer's Office on Thursday, September 22, 2022 from 10 a.m. to 2 p.m. Clerk Hoffenberg noted that the only form of payment which will be accepted at the event will be checks since electronic forms of payment have a challenging time being completed from our facility in a timely manner.

19. Committee on Youth – Trustee McDonald stated that the Summer Youth Intern Program run by the Township will be coming to a close on September 1, 2022. Trustee McDonald stated that the program had been successful in pairing twenty youth to various employers in and around the Township since May 31, 2022.

- 20. Mental Health Commission Trustee Porfirio reported that the Lyons Township Mental Health Commission was represented at National Night Out in Brookfield and Bridgeview, Illinois by Executive Director Ron Melka, and Administrative Assistant Jazmin Lopez respectively on August 2, 2022.
- 21. Trustee Porfirio stated that the "988" National Suicide and Crisis Safeline began service on July 16, 2022 and that Illinois calls went from 185 to 5,000 per month.
- 22. Trustee Porfirio commented that Executive Director Ron Melka testified at a special meeting of the Vernon Township Board in Lake County, Illinois who were considering placing a referendum to create a Community Mental Health Board on their November Ballot. Director Melka presented the Lyons Township Annual Report and walked them through the various functions and activities that our Board accomplishes on behalf of our residents. Trustee Porfirio stated that ultimately the Vernon Township Board voted unanimously to place a referendum to create a Community Mental Health Board on their November Ballot.

- 25. New Business Supervisor Getty commented that the Township of Lyons' Highway Department has been seeking a \$1,000,000.00 grant to help alleviate flooding in the unincorporated areas of the Township. This venture is in tandem with the Metropolitan Water Reclamation District (MWRD). Supervisor Getty deferred discussion on this topic to Township of Lyons' Highway Commissioner Sean McDermott.

- 26. Commissioner McDermott stated that approximately fifteen homes have been identified by the MWRD in the vicinity of 52nd Street and Linden Lane in La Grange Highlands as being prone to severe flooding. MWRD stated that 5-6 of the houses always flood and that Township of Lyons' and MWRD engineers have suggested that a mitigation measure to prevent the flooding would be for the Township to purchase a particular property within that group and to install a retention pond in its place. Commissioner McDermott stated that the Township would be paid back by the MWRD for the purchase of the home and property while the Township would be solely responsible for the engineering and the legal aspects of the project. The entire project is contingent upon whether the present homeowner would be willing to sell their property. Supervisor Getty commented that for the Township to purchase the property, a Special Town Meeting would have to be called and have at least fifteen electors present to vote on the proposal. Legal is also still in the process of discovering other logistics of the entire proposed project. Commissioner McDermott hopes that there will be progress made on this topic within the next month.
- 27. Supervisor Getty reported that it was brought to his attention via the Clerk's Office that the regularly scheduled Lyons Township Board of Trustees meeting for the month of November conflicts with the Illinois Gubernatorial Election and that it will need to be rescheduled to a different date. A suggested rescheduled date is Monday, November 14, 2022. Supervisor Getty stated that a vote for the new date will be placed upon the September 13, 2022 Regular Board Meeting Agenda.
