- 2. Supervisor Getty called the Meeting to order at 6:00 p.m.
- 3. Supervisor Getty called for the Pledge of Allegiance.

- 10. Supervisor Getty deferred the monthly Special Police Report to Trustee Mark Anderson which will be given under Agenda Line Item #14 "Special Police Protection".
- 11. Clerk Hoffenberg stated that the Township of Lyons has a robust group of interns this year and one of them in attendance at tonight's Regular Board Meeting, Aneta Garbacz, would like to come forward and address the Board concerning her project. Summer intern Aneta Garbacz came forward and addressed the Township of Lyons Board of Trustees regarding the Back to School Supplies Donation Drive that she is spearheading. Ms. Garbacz reported that she has seen first-hand, many students struggle in classes when they do not have the needed / required school supplies necessary for proper educational instruction. Ms. Garbacz commented that the school supplies she is seeking can be purchased via the Amazon QR code that she reproduced on the fliers advertising the drive and can be sent directly to the Township for sorting. Ms. Garbacz stated that she would like to have all donations by the end of business July 30th so that distribution of the items to those in need may be able to take place by mid-August.
- 12. Clerk Hoffenberg reported that the next Chair Yoga Class will be held on Thursday, July 17, 2025 at 1:00 p.m.
- 13. Clerk Hoffenberg stated that the Clerk's Office will host an Arts & Crafts Crafternoon on July 9 & July 14, 2025 from 2:30 4:00 p.m. and an Ice Cream Social on Thursday, July 10, 2025 from 2:30- 4:00 p.m. Families are invited to come to the Ice Cream Social.

14. Clerk Hoffenberg commented that the Arts & Crafts Crafternoon and the Ice Cream Social events were initiated via the Township Summer Interns that are working to increase senior programs in the Township of Lyons.

- 15. Clerk Hoffenberg stated that there will be a Repair Café on July 19, 2025 from 10 a.m. 1 p.m. Knife sharpening will be available and an I-CA\$H representative from the State of Illinois' Treasurer's Office will be on hand to check for any lost or forgotten monies which may be due to residents in attendance.
- 16. Clerk Hoffenberg commented that the Clerk's Office will host an AARP Safe Driver Course on July 29 & July 30, 2025 from 10:00 a.m. 2:00 p.m. each day. Participants must attend both days to receive credit on their auto insurance for a three year period.
- 17. Clerk Hoffenberg reported that a box has been set up outside of the Clerk's Office for donations of Pet Supplies. Donations to the box are due August 4.
