- 9. Clerk Hoffenberg reported that her entire staff together with the Township of Lyons' Mental Health Office had a meeting last week to plan the next six months of events happening through both offices and that the tentative schedule is included in each Trustee's Physical Board Packet tonight.
- 10. Clerk Hoffenberg stated that the Clerk's Office will be hosting "Pizza & A Movie" on Tuesday, September 16, 2025 at 11:30 a.m. "Moonstruck" will be the movie and all are invited to come.
- 11. Clerk Hoffenberg commented other events that are coming up include a Chair Yoga Class on September 18, a Repair Café on September 20th, a Fraud Protection & Advocacy Presentation for Seniors on September 24, and a Shred Event on Saturday, October 4 from 8 a.m. 12 noon.

Clerk Hoffenberg commented that Highway Commissioner Terry Carr had a 12. sign made for the pollinator garden that was recently planted at the Township of Lyons' Road District Office in honor of retired Highway Department employee Kathleen Rosenbeck for all her years of service. The sign was shown to all in attendance and was met with great approval. Commissioner Carr stated that the sign will be installed this week.

- Highway Commissioner's Report Commissioner Terry Carr reported that 14. his department is currently completing several drainage projects, have replaced approximately one-third of the traffic signs in the unincorporated areas of the Township, are continuing seasonal road maintenance and will shortly begin the 2025 drainage improvement project at Laurel Avenue and 65th Street.

- 17. Senior Transportation Trustee Mares stated that on average there has been ten to twelve new riders each month. Trustee Mares also welcomed Quinn Corcoran back from his leave of absence and thanked the staff for their hard work.
- 18. Committee on Youth –Trustee Cruz reported that the Township of Lyons' Summer Youth Intern Work Program ended on September 6, 2025 and that seventy-one interns worked a total of 19,455 hours in twenty-four locations within the Township of Lyons. Trustee Cruz stated that this year had the greatest number of interns ever and looks forward to the program's return in the summer of 2026.
- 19. Mental Health Commission Township of Lyons' Mental Health Commission President, Elyse Hoffenberg, deferred to the report which can be found in each board member's physical board packet.

Special Police Protection Trustee Anderson reported that for the month of August, sheriff officers completed 293 premise checks, performed five traffic stops, issued ten traffic tickets, made one traffic arrest, and completed sixteen school premise checks within the unincorporated areas of Lyons Township.

- To Clerk Elyse Hoffenberg, Mr. Sochacki thanked her for running the Electronic Recycling event in Bridgeview.
- To Supervisor Getty and the Board of Trustees, Mr. Sochacki stated that he just wanted to inform all in attendance that he had seen the Township of Lyons' Senior Transportation Buses on two occasions, August 21 and August 23, parked off Township premises after hours. Asking why, he was told that they were found parked where they were because they were awaiting regular maintenance and / or repairs to be done at a neighboring auto repair shop.
- To Highway Commissioner Terry Carr, Mr. Sochacki asked how the Highway Department was able to install stop signs in the area when Mr. Sochacki had asked at a prior Board Meeting if one could be installed where he lived and was told "No.", to which Commissioner Carr answered that his department had been only installing replacement stop signs due to wear and were not installing new ones.
- To Clerk, Elyse Hoffenberg, Mr. Sochacki asked why his request for certain Senior Transportation records was not granted, to which Clerk Hoffenberg responded that Supervisor Getty held on to the records which Attorney Lauren DaValle had sent over to him regarding the request and that they were never forwarded to her. Clerk Hoffenberg, having heard no response from Supervisor Getty, thought that the request had not yet been finalized.
