1. The Board of Trustees of the Township of Lyons held its Regular Board Meeting on Tuesday, December 9, 2025 in the Town Hall, 6404 Joliet Road, Countryside, Illinois 60525.

2. Supervisor Getty called the Meeting to order at 6:02 p.m.

3. Supervisor Getty called on former Township of Lyons' Supervisor, the Honorable Russ Hartigan, to lead the Pledge of Allegiance.

21. *Mental Health Commission* – Township of Lyons Mental Health Commission President, Elyse Hoffenberg, stated that at the last Township of Lyons' Regular Board Meeting an Ordinance was passed to bring the number of Mental Health Commissioners on the Mental Health Board back down to seven according to state statute (405 ILCS 20) under which the Township of Lyons' Mental Health Commission was formed. President Hoffenberg commented that to comply with the state statute three current members would have to be dropped from the Board. Thus, the Honorable Russ Hartigan, Steve Palmer and William Seith would be removed.

22. Township of Lyons Mental Health President Elyse Hoffenberg and Township of Lyons' Supervisor, Christopher Getty, expressed their heartfelt thanks for the service that Hartigan, Palmer and Seith had contributed to the Mental Health Board over the years and for what was accomplished under their leadership. President Hoffenberg did state that a small reception would take place immediately after the current Township of Lyons' Board Meeting to honor them to which all are invited to attend.

23. *Special Police Protection* – Trustee Anderson reported that for the month of November, sheriff officers completed 218 premise checks, thirteen traffic stops, issued fifteen traffic tickets and two warning tickets, within the unincorporated areas of Lyons Township.

26. *Public Comment* – Township Resident Mike Sochacki, 8701 Wolf Rd., Burr Ridge, IL 60527 addressed the board as follows:

- Mr. Sochacki asked how much the increase in the Levy was going to cost the average homeowner to which Supervisor Getty stated that it was approximately \$0.60 per \$250,000.00 of the appraised value of one's home.
- Mr. Sochacki asked if the cities / villages within the Township of Lyons ever reimburse the Township for using the Senior Transportation buses for transporting Seniors from across the Township to the various village / city events that occur throughout the year. Supervisor Getty responded, "No."
- Mr. Sochacki inquired if the Township of Lyons had any written policy regarding which organizations within the Township were eligible for community event funding. Clerk Hoffenberg stated that the Township of Lyons has a Discretionary Grants Awarding Policy for such funding that was written in 2011 and will give Mr. Sochacki a copy.

- Mr. Sochacki commented that he would like to see the monies that the Township of Lyons grants to the various communities within the Township be more widespread so that more residents would benefit. Mr. Sochacki feels that too much is spent / given to the targeted communities of Summit, Bridgeview, and Justice.
- Mr. Sochacki stated that he would like to see more patrols by the Sheriff's Department along Willow Springs Road between 82nd and 87th Avenues due to excessive speeding.
